diligence ehs auditing process safety auditing and a chapter summarizing auditing with the relevant iso standards the rest of the book has been updated to fit with the guidance and requirements set out with the changes in the iso standards the goal of this book remains the same to provide a down to earth guidance for managers and specialists in organizations who are committed to improving their safety health and environmental performance but are not sure where to start or do not wish to employ consultants to do this for them they do it themselves using this book features integrates the concepts of safety health and environmental auditing into a common approach of loss prevention provides an audit protocol for 60 aspects of safety health and environmental management presents a summary of the requirements of iso 9001 and iso 14001 to auditing introduces the novel and unique concept of auditing convergence offers a simple auditing software the plaudit ii audit process in an electronic program which no other book on this topic can offer each year there are improvements in safety critical system technology these arise both from developments in the contributing technologies such as safety engineering software engineering human factors and risk assessment and from the adoption or adaptation of appropriate techniques from other domains such as security for these improvements to be of real benefit they need to be applied during the appropriate stage in the life cycle of the system whether it be development assessment or operation for this to occur
