arguments that preceded them which answers can international law provide for the ending of wars and which challenges remain or have recently arisen this volume addresses these questions and enables both an understanding of how the end as a concept informs the understanding of war in international relations in international law and in history as well as a reconsideration of the nature of scientific method in the field of war studies as such the chapters in this book were originally published as a special issue of the journal of strategic studies war is a fact of human nature as long as we exist it exists that s how the argument goes but longtime scientific american writer john horgan disagrees applying the scientific method to war leads horgan to a radical conclusion biologically speaking we are just as likely to be peaceful as violent war is not preordained and furthermore it should be thought of as a solvable scientific problem like curing cancer but war and cancer differ in at least one crucial way whereas cancer is a stubborn aspect of nature war is our creation it s our choice whether to unmake it or not in this compact methodical treatise horgan examines dozens of examples and counterexamples discussing chimpanzees and bonobos warring and peaceful indigenous people world war i and vietnam margaret mead and general sherman as he finds his way to war s complicated origins horgan argues for a far reaching paradigm shift with profound implications for policy students ethicists military men and women teachers philosophers and any engaged citizen ending the u s war in iraq required redeploying 100 000 military and civilian personnel handing off responsibility for 431 activities to the iragi government u s embassy uscentcom or other u s government entities and moving or transferring ownership of over a million pieces of property in accordance with u s and iragi laws national policy and dod requirements this book examines the planning and execution of this transition many books have been written about war but few have focused on how wars can be brought to an end wars are rarely inevitable however and this book is aimed at understanding how violent conflicts can be brought to a close through intervention mediation and political negotiation the simple premise underlying the book is that wars between states and wars within states are generally fought by rational people for particular political goals or perceived interests war is better understood as a methodology rather than an ideology when the context issues and actors in these armed conflicts change then it is often possible to control or even transform such violence by bringing together a number of existing debates from peace and conflict research as well as scholars of international relations the book examines the dynamic forces that lie behind the ending of wars and how these have changed over time examples are drawn from a wide range of armed conflicts to analyse the efforts that have been made to move from war war to jaw jaw or more typically jaw war efforts at third party intervention mediation and political negotiation across a range of conflict zones from europe to sub saharan africa are discussed in full neither idealistic nor fatalistic this book is a must read for all students of international politics and security studies every war must end analyzes the many critical obstacles to ending a war an aspect of military strategy that is frequently and tragically overlooked ikli considers a variety of examples from twentieth century history and examines specific strategies that effectively won the peace in the new preface ikli

the world war in may 1945 by bringing to life the cultural imaginaries and practices of the past the book raises ostensibly intractable questions on the epochal impact of what often appears as inconsequential the typically unseen and seemingly banal power of everyday experiences this book is a judicial military and political history of the period 1941 to 1954 as such it is also a united states legal history of both world war ii and the early cold war civil liberties mass conscription expanded military jurisdiction property rights labor relations and war crimes arising from the conflict were all issues to come before the federal judiciary during this period and well beyond since the supreme court and the lower courts heard appeals from the government s wartime decisions well into the 1970s a detailed study of the judiciary during world war ii evidences that while the majority of the justices and judges determined appeals partly on the basis of enabling a large disciplined and reliable military to either deter or fight a third world war there was a recognition of the existence of a tension between civil rights and liberties on the one side and military necessity on the other while the majority of the judiciary tilted toward national security and deference to the military establishment the judiciary s recognition of this tension created a foundation for persons to challenge governmental narrowing of civil and individual rights after 1954 kastenberg and merriam present a clearer picture as to why the court and the lower courts determined the issues before them in terms of external influences from both national and world wide events this book is also a study of civil military relations in wartime so whilst legal scholars will find this study captivating so will military and political historians as well as political scientists and national security policy makers first published in 1996 the first world war was the single most important event of the twentieth century this volume concentrates on non u s aspects of the conflict organized alphabetically its more than 600 detailed entries offer information and insight on such subjects as the causes of the conflict major battles and campaigns weapons systems including military aviation chemical warfare the submarine and the tank and the terms of the peace some 350 biographies provide information on the roles played in the conflict by generals admirals and civilian leaders there are also biographies of individuals who were shaped by the war such as charles de gaulle adolf hitler benito mussolini and joseph stalin essays on each of the countries involved in the conflict new appraisals of such subjects as military medicine and artillery tactics and essays on such diverse subjects as art literature and music in the war each entry has references for additional reading and a subject index provides easy access the volume is an excellent reference source for scholar and neophyte alike milwaukeeans greeted the advent of world war ii with the same determination as other americans everyone felt the effect of the war whether through concern for loved ones in danger longer work hours consumer shortages or participation in war service organizations and drives men and women workers produced the essential goods necessary for victory the vehicles weapons munitions and components for all the machinery of war but even in wartime there were labor conflicts fueled by the sacrifices and tensions of wartime life a city at war focuses on the experience of working men and women in a community that was not a wartime boom town it looks at the stands of the cio and the afl against low wartime wages and at women in

unionized factories facing the perceptions and goals of male workers union leaders and society itself here is a social history of wartime milwaukee and its workers as they laid the groundwork for a secure postwar future hours after attacking pearl harbor on december 7 1941 japanese bombers stormed across the philippine city of baguio where seven year old curt tong the son of american missionaries hid with his classmates in the woods near his school three weeks later curt his mother and two sisters were among the nearly five hundred americans who surrendered to the japanese army in baguio child of war is tong s touching story of the next three years of his childhood as he endured fear starvation sickness and separation from his father while interned in three different japanese prison camps on the island of luzon written by the adult tong looking back on his wartime ordeal it offers a rich trove of memories about internment life and camp experiences relegated first to the men s barracks at camp john hay curt is taken under the wing of a close family friend who is also the camp s civilian leader from this vantage point he is able to observe the running of the camp firsthand as the war continues and increasing numbers of americans are imprisoned curt s days are occupied with work detail baseball and childhood adventures along with his mother and sisters he experiences daily life under a series of camp commandants some ruling with intimidation and cruelty but one memorably with compassion in the last months of the war the entire family is finally reunited and their ordeal ends when they are liberated from manila s bilibid prison by american troops child of war is an engaging and thoughtful memoir that presents an unusual view of life as a world war ii internee that of a young boy it is a valuable addition to existing wartime autobiographies and diaries and contributes significantly to a greater understanding of the pacific war and its impact on american civilians in asia this unique new work of reference traces the origins of the modern laws of warfare from the earliest times to the present day relying on written records from as far back as 2400 bce and using sources ranging from the bible to security council resolutions the author pieces together the history of a subject which is almost as old as civilisation itself the author shows that as long as humanity has been waging wars it has also been trying to find ways of legitimising different forms of combatants and ascribing rules to them protecting civilians who are either inadvertently or intentionally caught up between them and controlling the use of particular classes of weapons that may be used in times of conflict thus it is that this work is divided into three substantial parts volume 1 on the laws affecting combatants and captives volume 2 on civilians and volume 3 on the law of arms control this second book on civilians examines four different topics the first topic deals with the targetting of civilians in times of war this discussion is one which has been largely governed by the developments of technologies which have allowed projectiles to be discharged over ever greater areas and attempts to prevent their indiscriminate utilisation have struggled to keep pace the second topic concerns the destruction of the natural environment with particular regard to the utilisation of starvation as a method of warfare and unlike the first topic this one has rarely changed over thousands of years although contemporary practices are beginning to represent a clear break from tradition the third topic is concerned with the long standing problems of civilians under the occupation of
