sales and use tax texas comptroller of public accounts

texas imposes a 6 25 percent state sales and use tax on all retail sales leases and rentals of most goods as well as taxable services local taxing jurisdictions cities counties special purpose districts and transit authorities can also impose up to 2 percent sales and use tax for a maximum combined rate of 8 25 percent

the main difference between the two is that sales tax is a tax on the sale of tangible personal property while use tax is a tax on the use of that property within a state sales tax is generally charged by the seller at the time of the sale while use tax is typically self assessed by the purchaser when the seller has not charged sales tax
