**additional director appointment regularization and procedures** May 12 2024 an additional director is an individual appointed by a company s board of directors after its initial formation this appointment can occur during a special board meeting or at the annual general meeting

*additional director provisions section 161 1 companies* Apr 11 2024 if the board of directors wants one or more directors to be appointed in a company for any reason and cannot wait till the general meeting the board of directors may appoint an individual as an additional director only if they have given power in articles of association of the company

**difference between director additional director tax guru** Mar 10 2024 concept of additional director in accordance with the section 161 1 of the companies act 2013 a company may appoint any person as additional director other than the person who has failed to get appointed in the general meeting

**procedure for appointment of additional director lawrbit** Jan 08 2024 the proposed additional director has to submit form dir 2 consent to act as a director and form dir 8 intimation by director about his disqualification to the company such person shall also give a declaration that he fulfills the conditions for appointment as a director

**additional director of company how to appoint an additional** Dec 07 2023 a new director appointed by the board of directors of the company to the board is called as additional director such a director shall hold the office only up to the next annual general meeting of the company and shall continue to act as a director only if the shareholders pass a resolution in the next general meeting

**appointment of additional director in a company corpbiz** Feb 26 2023 a director is appointed by stakeholders of the company at the time of annual general meeting of the company whereas in contrast an additional director is nominated by the board of directors during board meeting as per section 161 of the companies act

*difference between director additional director* Jan 28 2023 a director is appointed by the members of a

company in the general meeting by passing an ordinary resolution whereas an additional director is appointed by the board by passing a board resolution

*types of directors under companies act 2013* *ipleaders* Dec 27 2022 if a person does not get appointed as a director in a general meeting then he cannot be appointed as additional director an additional director can be a managing or a whole time director an additional director can also be considered a rotational director *appointment of additional director under companies act* Nov 25 2022 an additional director on a company board is not a member of the board but is appointed by a member of the public or by shareholders this person does not have to be an employee of the company and can be any individual with expertise in his or her field of responsibility
