a substantial body of evidence demonstrates that social isolation presents a major risk for premature mortality comparable to other risk factors such as high blood pressure smoking or obesity as older adults are particularly high volume and high frequency users of the health care system there is an opportunity for health care professionals to identify prevent and mitigate the adverse health impacts
