rather the matching of a well defined and phonologically articulated syntactic domain with conceptual content itself outside the domain of language as such in a departure from most current models of syntax but in line with many philosophical traditions then the exo skeletal model partitions meaning into formal functions on the one hand and content on the other hand while the former are read off syntactico semantic structures as is usually assumed content is crucially read off syntactico phonological structures
