the ministry of corporate affairs mca vide its circular in november 2013 had clarified that section 372a of the companies act 1956 would continue to remain in force till section 186 of the companies act 2013 the act is notified

section 372a of the companies act makes u aware of the provisions regarding intercorporate loans and investments this section also covers the guarantees and securities pledged for the grant of loans between corporates

## ***lesson 16 inter corporate loans investments guarantees and Dec 20 2023***

further the exemption available from the provisions of section 372a of the 1956 act to private companies as well as loans or investment given or made by a holding company to its subsidiary company are no longer available under the 2013 act

mca has now clarified that sec 372a of the companies act 1956 dealing with inter corporate loans continues to remain in force till sec 186 of companies act 2013 is notified text of the notification is as follows general circular 18

### **mca clarification under section 372a 3 of the companies act *Oct 18 2023***

section 372a 3 of the act inter alia provides that no loan to any body corporate shall be made at a rate of interest lower than the prevailing bank rate being standard rate made public under section 49 of the reserve bank of india act 1934 2 of 1934

### **company law intercorporate loans and investments under *Sep 17 2023***

the companies act 1956 contains provisions and restrictions on intercorporate loans and investments under section 372a broadly the provisions are summarised as under 1 a company cannot directly indirectly a make loan to any other body corporate b give guarantee provide security in connection with any loan by any other person

section 372a 8 d in the companies act 1956 d to any guarantee given or any security provided by a holding company in respect of loan made to its wholly owned subsidiary or

***comparison of section 186 of companies act 2013 and section Apr 12 2023***

section 372a of 1956 act covers only body corporate whereas section 186 of the 2013 act covers peron s and body corporate the word person has not been defined under the 2013 act as per section 2 31 of the income tax act 1961 person includes

***section 186 of the companies act 2013 and its caclubindia Mar 11 2023***

section 186 in the companies act 2014 herein after referred to as the act corresponds to section 372a in the erstwhile 1956 act the intention of both the provisions is by and large identical namely to regulate primarily inter corporate investments and loans

***section 372a of the companies act pdf guarantee loans Feb 10 2023***

section 372a of the companies act 1956 regulates inter corporate loans investments guarantees and security between companies it sets an aggregate ceiling limit of 60 of a company s paid up capital and free reserves or 100 of its free reserves for these activities

***section 372a co act ii pdf securities finance scribd Jan 09 2023***

section 372a provides a combined limit of 60 of paid up share capital and free reserves or 100 of free reserves for inter corporate loans guarantees and investments it also includes built in checks like requiring consent of all directors for such transactions
