cepol aims is to bring together senior police officers from across europe to share research and best practice to encourage cross border cooperation in the fight against crime and to help facilitate training and exchange programmes between european police forces however in march 2013 the commission presented a proposal for a new europol regulation one effect of which would have been to merge cepol with europol the committee the government the directors of europol and cepol the european parliament and the council all opposed the proposed merger a separate regulation on cepol was therefore proposed the new draft regulation would allow cepol broader objectives and

modernised governance the government supports the work of cepol but is unhappy with a number of proposals in the regulation including the removal of the requirement that all attendees on cepol courses should be senior police officers and the suggestion that member states should designate a national unit to contribute to cepol s work programmes the committee points out that there are legal reasons why the uk must at some stage opt in to the regulation it recommends that the government to do so now to give the uk a place at the negotiating table when the draft regulation is discussed

regulation but nonetheless it is recommended that the government should opt in given the important work undertaken by eurojust and in light of the provisions dealing with the proposed eppo the need for the uk to participate in the negotiations in order to improve the regulation

## National Parliaments after the Lisbon Treaty and the Euro Crisis

during the committee's investigation into the devolution of public finances lord palmerston's assessment of the schleswig holstein question has often sprung to mind funding of devolved administrations particularly with regards to scotland is a complex mix of social economic and political questions you would not start from here has been the lament of many of our witnesses this inquiry was prompted by the smith commission agreement the scottish cross party smith commission was established by the prime minister following the september 2014 referendum on scottish independence to agree further powers which should be devolved to scotland the committee was particularly interested in the proposals that seek to increase the financial accountability of the scottish parliament the smith commission agreement will be delivered through the scotland bill 2015 and the renegotiation of the fiscal framework by the uk and scottish governments the fiscal framework sets out how scotland wales and northern ireland receive funding from the uk

## **The Eurojet Regulation: Should the UK Opt-In? - HL 66**

this book analyses the horizontal effect of fundamental rights in the european union from a constitutional perspective it advances two main arguments first it argues that the horizontal effect of fundamental rights i e their application to disputes between private parties cannot be usefully discussed based on the existing eu horizontality doctrine which associates horizontality with the exercise of horizontal direct effect only that doctrine is characterised by a series of overly technical rules as to how the latter may be produced and has a case specific nature that lacks overall constitutional coherence secondly the book argues that a substantive theory

of horizontality is required in eu law and sketches its main parameters in the fundamental rights context horizontal effect has organisational implications for society which go beyond specific intersubjective disputes it is argued that its determination requires an explicit recognition of the public character of certain private platforms of will formation e g the workplace and a discussion of the role of fundamental rights therein at the same time a constitutionally adequate model of horizontality involves an acknowledgment of the supranational character of eu adjudication the determination of horizontal applicability of a fundamental right within a type of private authority relationship falls upon the court of justice but the precise manifestation of horizontal effect e g direct indirect or state mediated effect rests with national courts

following a defeat in the house of lords on the draft tax credits income thresholds and determination of rates amendment regulations 2015 the government asked lord strathclyde to examine how the government might secure their business in parliament and to consider how to ensure the decisive role of the elected house of commons in relation to its primacy on financial matters and secondary legislation there are indeed serious problems with the current system of delegated legislation that must be addressed but by tasking lord strathclyde to consider the balance of power between the two houses of parliament it seems to us that the government focused his review on the wrong questions it consequently addressed the wrong issues we believe that the more serious concerns arising from the delegated legislation process are rooted in the relationship between parliament and the executive for that reason our report examines not only the options considered by

the strathclyde review but wider issues relating to the delegated legislation process that were outside the remit of that review successive governments have proposed primary legislation containing broad and poorly defined delegated powers including henry viii powers that give wide discretion to ministers often with few indications as to how those powers should be used this committee and others have noted a trend whereby delegated legislation has increasingly been used to address issues of policy and principle rather than to manage administrative and technical changes

the government s progressive work on tackling violence against women and girls abroad is not translating into its domestic policy despite its violence against women and girls action strategy and the home secretary s personal commitment to the issue the committee warns that failure to provide adequate refuge spaces and specialist services for victims of violence against women and girls demonstrates the difficulty for the government in fulfilling its international obligations under the convention when decisions over commissioning of certain services has been

devolved the committee also expresses alarm at the prevalence of violence against women and girls across many cultures in the uk today and heard troubling evidence from many minority groups that represent women with particular needs the portrayal of women as victims of violence is deeply embedded in cultural stereotypes in the depiction of women in the media and in how women are treated in the asylum system this has to stop the committee s recommendations include that schools should play a greater role and include issues of violence against women and girls within the pshe curriculum whilst the government has taken steps to engage with the media and with public awareness campaigns to counteract the sexualised portrayal of women noting that the bbc declined invitations to give evidence to this inquiry the media themselves should do more the government look again at the payment of universal credit to couples because of its concerns that it could put women subject to domestic violence at risk
